**PAYMENT PLANS:** There are four payment plans offered by Harrells Christian Academy: annual, semi-annual, and two monthly plans. All tuition payments (including Annual) should be made through FACTS. Annual payments are due in July 2026. Semi-annual (July and December), 10-month (Aug – May), and 12-month (June – May) plans are paid by bank draft or credit/debit card through FACTS Tuition Management.

**ADMISSION FEE:** The admission fee is due, along with the enrollment contract, in the spring of the year before enrollment for kindergartners and for returning students, or upon acceptance.

**NEW STUDENT FEE:** This one-time fee is \$250 per student with a maximum of \$500 per family and is due with the Admission Fee. A new student is one who has not been continuously enrolled at HCA since initial acceptance.

**WITHDRAWAL FEE:** This \$500 fee applies to any student who withdraws from HCA between July 1 and April 30 of the current school year for any reason. Full monthly tuition will be charged through the last day attended. Refunds will be given for accounts paid beyond the current month.

**LATE PAYMENT POLICIES:** A 1% per month late fee will be assessed by HCA for charges that are past due.

Attendance may be suspended for students whose account is 90 days past due.

Enrollment will not be allowed for a new school year with any unpaid balance from the prior school year.

Enrollment will not be allowed for the spring semester if the fall semester is not paid through November.

Enrollment for the subsequent school year will not be allowed if the account is 90 days past due. Once the account is current, enrollment will be allowed.

**DISCOUNTS:** For families with **three or more children** enrolled at HCA, the third (and following) child's tuition will be discounted **25%** after the admission fee. This discount is applied to the **second** child or class in The Learning Center.

**FINANCIAL ASSISTANCE:** Financial assistance is available for students whose families demonstrate financial need. The application process is available online at [www.harrellsca.com](http://www.harrellsca.com) under the "Apply" heading for those students who have applied to Harrells Christian Academy. A copy of your federal income tax return from the previous year is also required.
